

Manufacturer's Limited Warranty

Anatoliy Stone subject to the conditions and limitations listed below, warrants its Products to be manufactured in accordance with our specifications and to be free from manufacturing defects.

Anatoliy Stone warrants its Products for a period of fifty (50) years to the original purchaser (based upon the date of purchase, date of completion of the installation if professionally installed, or date of settlement purchase of a newly constructed building, whichever is applicable). This warranty is non-assignable or transferable.

Anatoliy Stone does not cover any damage to the Products due to any cause not stated herein. This warranty strictly does not cover any issues with non-defective material caused by conditions or handling beyond our control. Some examples of conditions not covered by this warranty are as stated: Improper Installation or installation not in strict compliance to the applicable installation instructions or installation not in accordance with local building code requirements, willful abuse, negligence, misuse or damage resulting from lightning, fire, building or structure settlement and movement, contact with chemicals or paint, discoloration due to airborne contaminants, staining or oxidation, any acts of God or any other such occurrences beyond the control of Anatoliy Stone.

If the Manufactured Product be proven defective during the warranty period, Anatoliy Stone will, in its sole discretion option: 1) repair the defective product; 2) replace the defective product; 3) reimburse the price paid for the product. These are the only options for breach of warranty or other legal theory. In no case will Anatoliy Stone be responsible of labor costs for removal or replacement (installation) of its product.

SUBJECT TO THE ABOVE, THIS WARRANTY SETS FORTH ANATOLIY STONE PRODUCTS, INC.'S MAXIMUM LIABILITY FOR ITS PRODUCTS. IN NO EVENT SHALL ANATOLIY STONE BE LIABLE FOR ANY CONSEQUENTIAL OR INCIDENTAL DAMAGES OF ANY KIND, ANYWAY OCCASIONED, WHETHER BY NEGLIGENCE OR OTHERWISE. ANATOLIY STONE WILL NOT BE RESPONSIBLE FOR INDIRECT, SPECIAL, CONSEQUENTIAL OR INCIDENTAL DAMAGE. THE BUYER'S RIGHTS AND REMEDIES WITH RESPECT TO ANY AND ALL DAMAGES RESULTING FROM ANY CAUSE WHATSOEVER CONFERRED UPON YOU AS A USER OF PRODUCTS CANNOT BE EXCLUDED, RESTRICTED OR MODIFIED, BUT SHALL BE AS SPECIFIED ABOVE. IN THE EVENT STATE LAW PRECLUDES AN EXCLUSION OR LIMITATION OF IMPLIED WARRANTIES, DURATION OF SUCH WARRANTIES SHALL NOT BE LONGER THAN, AND THE TIME AND MANNER OF PRESENTING ANY CLAIM THEREON SHALL BE THE SAME AS, THAT PROVIDED IN THE EXPRESS WARRANTY STATED HEREIN.

The buyer's correspondence must include a) the product name; b) the claimed defects, including photographs; c) the identity of the person making the claim; d) the address where the defective product can be inspected; e) a phone number where the buyer can be reached. Anatoliy Stone Products, Inc., will investigate your claim within 90 days after notification and take appropriate action.
